| Voting Rights | <p>6. <u>Voting and Participation:</u></p> <p>(1) A Business Member who is not a sole trader shall not be entitled to exercise a vote or participate in any meeting provided for in these rules or in any activity of the Chamber except by a nominee appointed under these rules.</p> <p>(2) A Business Member who is not a sole trader shall upon becoming a member nominate in writing a natural person to be its representative for the purposes of paragraph (1).</p> <p>(3) Such nominee may at any such meeting exercise on behalf of the Business Member its right to participate and vote at any time but shall not otherwise be a member of the Chamber.</p> <p>(4) A Business Member may by written notice served on the Secretary at any time change such appointment.</p> <p>(5) Any such appointment or change of appointment shall become effective upon the name of the nominee being entered as such in the register of members.</p> <p>(6) A Business Member who is a sole trader shall be entitled to exercise a vote or participate in any meeting provided for in these rules or in any activity of the Chamber.</p> <p>(7) An Individual Member shall be entitled to exercise a vote or participate in any meeting provided for in these rules or in any activity of the Chamber.</p> |

| Fees | <p>10. <u>Fees, Subscriptions, etc:</u></p> <p>(1) Unless otherwise determined by the Committee an application for membership must include the Application Fee.</p> <p>(2) In addition to the Application Fee, a member of the Chamber shall pay to the Chamber before the 1st July in each calendar year an annual membership fee of such amount as is determined from time to time by the Committee, provided that where a member joins after the first quarter in any financial year the annual membership fee payable may be pro-rated at quarterly rests at the Secretary's discretion.</p> |
